The aim of the information day is to familiarise potential applicants with the Technical Assistance for Disaster Risk Management "Track 1" (UCPM-2024-TRACK 1) call for proposals and to provide useful guidance on the preparation of applications for this call published in January 2024.

This funding instrument provides financial support (with a rate of EU co-financing of 95%) to the national disaster risk management authorities of Member States and other participating states in the Union Civil Protection Mechanism for the development of strategic activities (including feasibility studies, proposals, policies and plans) which can leverage investments for greater disaster risk management impact.

The Technical Assistance for Disaster Risk Management call for proposals has been published on the Commission's <u>Funding & tender opportunities portal</u>, and information about the call is also available on the <u>Union Civil Protection Knowledge Network</u> website.
