IS AGREED WHAT FOLLOWS:

Preamble:

The thirty third edition of the festival *Les Boréales*, organized by Normandie livre & lecture, will welcome, side by side with other Nordic countries, Estonia, Latvia and Lithuania as special guests. From the 13th until the 23rd of November, the Estonian artistic scene will be put forward in Caen and in surrounding region. In order to help the organization of this program, the Ministry of Culture has accepted to contribute financially the festival.

This hereby contract confirms the financial and technical terms and conditions of our mutual understanding and agreement as follows:

Article 1: Purpose

This hereby contract aims at setting an amount and the terms of the undertaking of the Ministry of Culture and N2L for 2025.

Article 2: Grant of the Ministry of Culture

The Estonian Ministry of Culture agrees to provide a financial contribution of 20 000 euros (twenty thousand euros) VAT included, to be paid in euros via bank transfer to the N2L's bank account, upon receipt of a valid invoice sent to the Estonian Ministry of Culture.

The contribution shall be paid in two times:

- 15 000€ once this hereby agreement ratified and at the reception of the festival's program on October 14th 2025 within a two weeks delay
- 5 000€ at the end of the festival on December the 12th 2025

Article 3 : Estonian cultural program

The festival *Les Boréales*, commits to put forward the artistic scene of Estonia through these followings events – see the preliminary program in Annex.

Other Estonian events can still be added to the program of the festival.

Article 4: Communication

The contribution by the Estonian Ministry of Culture will be featured in festival's different communication channels, both printed and online.

Article 5: Validity time of the contract

This hereby contract setting the financial and technical agreements is signed for the year 2025.

Article 6: Termination of the contract and refunding of the perceived grants

In concertation with N2L, the Ministry of Culture could demand the partial refunding of the perceived grants in case of partial non-execution of the program by the Festival Les Boréales considering the reasons of this partial non-execution. This non-execution can be claimed if more than 25% of the events listed in Article 3 fail to be executed. In addition, The Ministry of Culture could also demand the total refunding of the grants in case of total non-execution of the program or the use of the account for other purposes that those mentioned in this hereby contract and for a part of the communication by the Festival Les Boréales.
