Superstructure + cutting extinguisher warranty: 36 months on a condition yearly service & maintenance is performed on the superstructure and cutting extinguisher as per manufacturer recommendations

Continuous corrosion for the superstructure and its base and/or intermediate and/or support frame: 15 years on a condition yearly inspections for rust perforation are performed on the superstructure elements, and any spotted corrosion sources are eliminated / fixed as per manufacturer recommendations

Rescue equipment supplied with the vehicle: 24 months

### I General terms and conditions

The Contractor is obliged to remove quality defects and installation defects only if they occurred during the warranty period, in accordance with the provisions of the Agreement.

The formal date of receipt of the vehicle by the Ordering Party / User is the starting date of the warranty period.

Warranty services are provided and performed exclusively by the company Szczęśniak Pojazdy Specjalne Sp. z o.o., authorized services of the chassis Manufacturer and Parties authorized by the Contractor.

The User is obliged to report the detected defect of the vehicle immediately, not later than within 14 days from the date of its detection, or from the day on which, with due diligence, he could detect this defect, under the pain of the loss of warranty rights. The application should be submitted at the company's headquarters:

At the request of the Contractor, the Ordering Party / User is obliged to present the Warranty Book, under the pain of the loss of warranty rights. In the case of a warranty report on the vehicle equipment, the Contractor is responsible for defects only at the moment of recognition of warranty by the Manufacturer of the equipment.

In the case of warranty claims, the Contractor has the sole decision on the method of repair or replacement of elements with new / regenerated ones. In the event of a reported failure caused by the User's fault, the costs of repair and any additional costs related to e.g. displacement of the device will be borne by the User. Each warranty repair should be certified in the Warranty Book.

If the description of fault is insufficient, warranty report will not be accepted.

## II Warranty exclusions

Activities and elements not covered by the warranty:

- Performing adjustments.
- Replacement / regeneration of consumables subject to normal wear and tear (including oils, fuels, suspension system, brake system, engine wear parts, tires, batteries, clutch discs, drive belts, filters, bulbs, fuses, wiper blades, spark plugs, etc.).
- Damage caused by non-compliance with the instructions in the operating manual.
- Damage resulting from accidents, vandalism, scratches and / or abrasions to the car body, as well as damage caused by them, weather phenomena and natural disasters.
- Damage caused by unauthorized interference in construction or sheathing.
- Calibration of systems and devices that are part of the vehicle or its equipment.

Entitlements under the guarantee will expire before the date on which they were granted if they meet among others one of the following components:

- Operation of the vehicle by unauthorized persons, ➣
- Operation of the vehicle inconsistently with its intended function,
- $\triangleright$ Failure to comply with the provisions of the operating manual,



- Failure to perform regular technical inspections designated by the Contractor.
- Execution of superstructure, reconstruction or modification of the vehicle without the prior written consent of the Contractor,
- Breakage or damage to security seals.

The Contractor shall be liable to the Purchaser only for the losses resulting from the fault of the Contractor, subject to the provisions of the Agreement or the mandatory provisions of law.

### III Water pump

The warranty period for the water pump begins upon receipt of the vehicle and continues as indicated at the beginning of the manual. The contractor guarantees that the device will be free from materials and production defects during the applicable warranty period.

The warranty does not cover elements subject to normal wear and tear. The warranty for the device is forfeited when, inter alia, one of the following:

- Using the device inconsistently with the vehicle bodywork operating manual and the Manufacturer's operating manual.
- The use of agents other than water and foaming agents approved for use.
- Transportation of drinking / sanitation water.
- Improper use,















- Performing repair / regeneration activities by unauthorized persons,
- Carrying out modifications / alterations of the water pump or the water-foam system without prior written consent of the Contractor.

## Moreover, the warranty does not cover:

- Normal wear and tear,
- Failure caused by the technical specification of the vehicle meeting the Ordering Party's tender requirements,
- Failure caused by the use of too much pressure, sudden closing / opening the valve at high pressure,
- Mechanical failures and damages caused by switching on / switching off the water pump's drive at high speed power transfer.
- Damages caused by the fault of the User,
- Failure, the cause of which can be attributed to non-factory components in-vehicle equipment.
- Failures caused by defrosting the system (resulting e.g. from improper drainage of the water-foam system),
- Failures due to overheating of the system.


The report of a failure related to the water pump must include the serial number of the device placed directly on the water pump, as well as on the rating plate.



## IV Fire extinguisher

Operating with an incomplete water and / or foam concentrate tank will void any warranty claims. The Szcześniak PS company is not responsible for any damage caused by moving with incomplete tanks.

The warranty does not cover damage caused by working at a pressure greater than indicated in the manual, as well as during refueling with substances other than those indicated by the Contractor.

When using a vehicle with a steel tank, it is necessary to perform regular disinfection (at least once a month) with chlorine dioxide based tablets and regular rinsing of the tank with water (every 14 days). When using a vehicle with a composite tank, the water in the tank must be changed regularly every 14 days. Periodically clean the tank cleaner in accordance with the vehicle operator's manual.

### V Chassis

inspections of the chassis should be performed accordance with the Manufacturer's recommendations or otherwise the vehicle warranty will be void. Terms of warranty under the terms of the Contractor's representative.
