

SINGLE PROCUREMENT DOCUMENT

The Single Procurement Document, i.e. the European Single Procurement Document (ESPD), is a self-declaration by an economic operator providing preliminary evidence replacing the certificates issued by public authorities or third parties. This PDF document prepared by the register is of explanatory nature and includes the criteria provided by the contracting authority, the view of the format of answers expected from economic operators and references to the Public Procurement Act (PPA) added by the register. This document has not been meant for filling in, but for examining the criteria. The economic operator fills in the Single Procurement Document electronically in the information system or in the ESPD service.
