Subject: CleanSeaNet Course: Advanced level, EMSA, Lisbon, 15 October 2026

Dear Sir/Madam,

The European Maritime Safety Agency would like to invite you to designate two persons from your country to register to the CleanSeaNet Course - Advanced level. The course is part of the EMSA maritime training services certified as per “ISO 29993:2017 - learning services outside formal education” developed by the EMSA Academy. This 1-day course is planned to be delivered at the EMSA premises in Lisbon on 15 October 2026 with the limit of 16 participants per session. Due to the limited number of seats, the participants will be selected on first come first served basis.

The course is aimed at designated at duty officers with experience using CSN service or managers responsible for the coordination of CSN service within its national administration including requesting EMSA’s support during emergencies, exercises and operations. The course also contains practical exercises to enable consolidation of knowledge acquired.

At the end of the course, a certificate will be provided verifying achievement of the intended learning outcomes, participation, and the demonstration of knowledge and specific skills. For those not passing the assessment, a certificate of attendance will be delivered attesting only their participation.

The course overview, its structure, the intended learning outcomes, agenda and other relevant information, are included in the attached **Course Guide (Annex I)**.

Kindly be informed that participation in the training is subject to the approval of the CSN National Competent Authority.

credentials: **Username: emsa.guest2026 / Password: Participants2026**. Once logged in, access the “EVENTS REGISTRATION” button and from there select the link to the CleanSeaNet Course for Advanced.

Before making any travel arrangements, please make sure that you have received a message confirming that your registration has been successful.

EMSA will cover travel, daily allowance and accommodation costs as per the EMSA Rules on Reimbursement of Expenses to Experts. With respect to the daily subsistence allowance, experts will receive **95 €** per day of meeting. As regards accommodation, experts will receive a flat rate of **121 €** per overnight stay (no supporting document required) for the invited participants. The maximum number of overnight stays reimbursed is the number of meeting days +1.

Please note that only registered participants will be entitled to reimbursement and all supporting documents for reimbursement must be submitted within 30 calendar days after the end date of the event.
