Please see my comments below your questions:

1. WP 4 Manual for local municipalities, Deliverable 4.1 Brochure Handbook for local municipalities: 100 paper copies and additional electronic version instead of 500 paper copies

In the project plan is pescribed that local municipalities handbooks should be printed in 500 copies. Due to the fact that Estonia had administrative reform in 2017, after what lot of local municipalities been reduced, there is no need for so many manuals. Today we have only 79 local municipalities, before the reform the number was 200. From the discussion with project team we decided that it would be most effective, if manuals for local municipalities will be printed in only 100 paper copies and we will also make electronic version of the manual what could be shared among local municipalities. Producing electronic version would be more effective mostly for local municipalities because electronic versions are easier to share and for police system it will give the opportunity to hold the manual always up-to-the date.

Somehow there is no budget line for the manuals in the project budget. Because of that, I would like to know if it is possible to cover the expenses of the manuals from the budget line 54 (seminar package 7x3). We foresee in that line some excess money. Also the manuals are conclusion of the training sessions, so using money from seminar package line would be reasonable. The cost for 100 paper copies printing and electronic version design, and linguistic editing would be around 1000-1500 euros, what is under 10% of the budget line. Is the amendment needed?- Generaly its ok for me if it's necessary for the project. But I have to see this transfer in the budget first. In the budget you have submitted the line 54 is unchanged . On the other hand you have changed line 51- is it a mistake?. So please send the updated budget with all the proposed changes indicated . Did you add the additional line for the manual costs? I don't find it , please put it in different color.

It is pescribed that video material production should be done by subcontract. We had discussion with our project team members and we decided that it would be more effective to use our own video production specialist. We have in our police department response unit a specialist, who is already made many of video materials regarded to tactical excercises and quick response to actions. He has a very good experience how to do these kind of videos and on what to pay special attention during the filming process. If we would take video production outside of the police system by subcontract it would be very difficult to get the maximum efficiency of that video. So if we would like to use this money from budget to cover the specialist work hours, do we have to make official amendment and also change the budget line headings or this announcement is enough. If we have to change the

headings, the E will change to heading A - staff costs. Its ok but please remove *subcontracting* from line 66

You made also changes in the line 27 and 28 (heading B) but you didn't mention them in the email.

Generally if the amount of the heading does not rise more than 10% (comparing to the last amended budget) then we can make modification by email.
