**Subject:** Consultation on Technical Specification of CPB-RHIB - SA ISF-Borders

Dear Mrs Kuivonen,

In accordance with paragraph 5.2 of Internal Security Fund Specific Actions (ISF/SA) pledge Exercise 2018 (Ref. Ares(2018)2591772 - 18/05/2018), the EBCG Agency assessed the Technical Specifications submitted by Estonia for the acquisition of a Coastal Patrol Boat (CPB)/RHIB as follows:

**1) Technical Consultation in line with Requirements:**

The Patrol Boat fulfils the minimum requirements as indicated in the Annex I of Maritime assets of the aforementioned Note, except of the thermal camera that is expected to be transferred from the category of optional equipment to mandatory. In the event that the purchase of this camera leads to exceeding the ceiling of the total budget, it is recommended to be substituted by a portable according to the Requirements established for this type of equipment.

**2) Suggestions:** The EBCG Agency suggest to:

- Equip the CPB/RHIB with electronic maritime maps displaying also the Mediterranean operational area where the Agency currently operates.
- Include Contract acceptance tests as follows:
  - a) Factory Acceptance Tests (FAT) for all major equipment, if applicable;
  - b) Harbour Acceptance Tests (HAT) (at the dock)
  - c) Sea Acceptance Tests (SAT) or Sea trials

The procedures of the above mentioned acceptance tests are recommended to be mutually agreed by the contractor and the customer to guarantee that before the execution of these tests all the relevant contractual requirements are duly fulfilled.

The European Commission can approve the launching of the procurement procedure after the compliance with the Technical Consultation in line with the Requirements (Paragraph 1). “
