Siseministeerium edastab vastused ÜRO majanduslike, sotsiaalsete ja kultuuriliste õiguste rahvusvahelise pakti täitmise 4. aruande lisaküsimustele.

II osa. Pakti üldsätted, artiklid 1–5

Diskrimineerimise keeld (art 2 lg 2), punktid 7-8 pagulased ja kodakondsus

Punkt 7: The draft bill 472 is being processed in the Riigikogu. The Reception Conditions Directive has been fully incorporated into the national law and its principles concerning the detention are being implemented accordingly. Access to healthcare and other basic services is guaranteed.

Free information on the rights and obligations and the legal counseling is provided for all applicants. There are 2 full time counselors appointed. Workplaces of the counselors are situated in the detention center and in the reception centers. Free legal help and representation is provided for all applicants who have received a negative decision and wish to submit an appeal to the court. During the period of 2015 to the end of the 2017 the State Legal Aid was applied and provided for on 118 times (for 94 persons).

Punkt 8: We do not gather data on the ethnic origin of the persons with undetermined citizenship. We only have information on the place of birth of those persons, but this does not indicate their ethnicity. More than 50% of persons with undetermined citizenship are born in Estonia.
