## Extension of the deadline for submitting nominations to serve on WHO governing bodies and committees for the nomination year 2025

Dear Sir or Madam,

In my previous correspondence dated 26 February 2025, I invited nominations to serve on WHO governing bodies and committees, namely on the Executive Board (EB) and the Standing Committee of the Regional Committee for Europe (SCRC), for the nomination year 2025.

The constitutional deadline of 28 April 2025 for submission of nominations has now expired. Below is an overview of the received nominations, which indicates that an insufficient number of nominations were submitted by Member States in Group B for the SCRC:

Consequently, it has been decided, in consultation with the members of the Thirty-second SCRC, to **extend the deadline for nominations** for this specific governing body and subregional grouping **until Wednesday, 11 June 2025**. For those WHO bodies and committees and their subregional groupings that received a sufficient or exceeding number of candidatures, the submission process is now closed.

I encourage Member States in Group B to consider submitting nominations. For comprehensive details regarding nomination requirements, please refer to my previous correspondence enclosed.

Further information about the nominations received will be shared with Member States following the finalization of the submission process.
