

## AMENDMENT OF PUBLIC CONTRACT NO 2-2/24/958

and

have concluded an amendment to the Public Contract No. 2-2/24/958 (hereinafter also referred to as the

the term “National Defense Investment Center” will be replaced by the term “Estonian Centre for  
Defence Investments”.
