

AGREEMENT

on Cooperation and Provision of Charitable Assistance

Volunteer Battalion Charitable Foundation (VB Foundation), hereinafter referred to as the "Recipient", represented by Yaremenko Volodymyr (Director), acting on the basis of the Statute, on the one hand, and the National Defence Promotion Fund (Republic of Estonia), hereinafter referred to as the "Donor", represented by Mait Palts (Chairman of the Board), acting on the basis of its founding documents, on the other hand, collectively referred to as the "Parties", have concluded this Agreement as follows:

1. Subject of the Agreement

- 1.1. The Donor transfers to the Recipient charitable financial aid in the amount of 3055.- EUR (three thousand and fifty-five euros).
- 1.2. The funds are provided for the family members of employees and academy staff of the State Criminal-Executive Service of Ukraine who have lost their lives as a result of the war.

2. Purpose and Use of Funds

- 2.1. The purpose of this Agreement is to provide funds for charitable assistance to the family members of employees and academy staff of the State Criminal-Executive Service of Ukraine who have lost their lives as a result of the war.
- 2.2. The Recipient undertakes to use the funds exclusively for the purposes specified in this Agreement.

3. Procedure for Transfer and Use of Funds

- 3.1. The Donor transfers the charitable assistance in a single payment to the official bank account of the Recipient.
- 3.2. The date of receipt of the funds shall be considered the date on which they are credited to the Recipient's bank account.
- 3.3. The Recipient shall allocate the received funds for the implementation of the activities specified in Clause 2 of this Agreement.

4. Rights and Obligations of the Parties

- 4.1. The Recipient undertakes to allocate the funds in accordance with the terms of this Agreement.
- 4.2. The Donor has the right to receive information regarding the allocation and use of the funds.

5. Term of the Agreement



5.1. This Agreement enters into force upon signature by the Parties and shall remain valid until full performance of the obligations.

5.2. The Agreement may be terminated by mutual written consent of the Parties or in other cases provided by law.

6. Final Provisions

6.1. This Agreement is executed in one copy and in English.

6.2. All disputes arising between the Parties in connection with the performance of this Agreement shall be resolved through negotiations.
