We discussed the matter internally and since these accounts have been all approved it should not be possible to change them retroactively.

The nature of the mistake seems however clerical, in that it does not affect any payments and, in addition, the ratio between the estimated EU contribution and the estimated cost of the project also points to the correct co-financing rate (75%).

If, as I understand, no further reporting is expected for the FY2024, then there is nothing to do. Otherwise, we should make sure that the correct co-financing is included in the final accounts (Oct 23-Jun 24).

I remain available should you need to further clarify the matter.
