## **IMPORTANT**

- 1. Please note that National IP Office staff may enroll for up to two of the above courses. However, candidates must complete the courses during the session they have registered for, as this offer is made on a scholarship basis.
- 2. The general deadline for registrations is **August 28**, **2024**. Registrations received after the deadline may not be processed and thus late applicants might not be able to access the courses in 2022. Please note that the National IP Office staff registration deadline is **August 23**, **2024** in order to guarantee your place in the courses. Registrations received after the National IP Office deadline may not be processed and thus late National IP Office applicants might not be able to access the courses in 2024.
- 3. Each National IP Office staff candidate enrolls on-line on the "WIPO eLearning Center". https://welc.wipo.int/
- 4. All candidates must create a WIPO User Centre Account prior to enrolling. First time enrollees will be prompted to create a WIPO User Account. Returnees will be prompted to recall their password, but if they do not remember their passwords, they may reset them.
- 5. **IMPORTANT:** Candidates should select "National IP Office" as their "Professional/Business Area" under the Occupation section; (without the selection of 'National IP Office') it would not be possible to proceed with registration for the course on a scholarship basis.
- 6. Each designated candidate should indicate in the field "E-mail Address of the Director of your IP Office" the e-mail address of the Head/Coordinator of the respective National IP Office. After submitting the on-line registration, the authority will automatically receive a letter notifying them that National IP Office staff member has registered.
