Commercial Register Act \S 30 stipulates that everyone has the right to examine a registry card of the commercial register. The data of a registry card of the commercial register may be accessed via the electronic commercial register (Commercial Register Act \S 31 subsection 1). Therefore, the e-mail address may not be hidden from public.

According to the law, the data in the e-Business Register are public to everyone. e-Business Register is the official portal that includes the data of companies of all legal entities and self-employed persons registered in Estonia in a single environment. The portal includes foremost information about legal entities (e.g. private limited companies, apartment associations), but also some data regarding the natural person associated with that legal entity (e.g. data of a member of the management board, data of a shareholder).

The data of the registry card (email address of the company) of the e-Business Register that are the general information regarding the legal entity and the right of representation are available to everyone and can be indexed (i.e. can be found in search engines).
