MS AMLIN MARINE NV TO BECOME MSIG SPECIALTY MARINE NV ALIGNING WITH THE MSIG EUROPE SE BRAND

Dear Sir or Madam,

We are pleased to announce that, as of 1 July 2025, MS Amlin Marine NV ("MSAM") will change its name to MSIG Specialty Marine NV. This change marks an important step in aligning our identity with the global MSIG brand and reflects our continued integration within the Mitsui Sumitomo Insurance Group.

The new name, MSIG Specialty Marine NV, reinforces our commitment to delivering expert, specialised marine insurance under a unified and globally recognised brand, while maintaining the same trusted team, services, and dedication to our clients and partners.

This rebranding takes place in the context of a broader alignment across our European operations. In June 2024, our shareholder, Mitsui Sumitomo Insurance, announced its intention to merge two of its European subsidiaries – MS Amlin Insurance SE ("MS AISE") and MSIG Insurance Europe AG ("MSIGEU") – into a single entity. Subject to consultations and regulatory approvals in Belgium and Germany, the merger is expected to become effective on 1 July 2025, upon which the new entity will be known as MSIG Europe SE.

We want to assure you that these changes are brand-related and structural only. There will be no disruption to our day-to-day operations, and our dedication to service excellence remains unchanged.

Our foremost priority is to ensure stability for our partners and a seamless continuation of our collaboration.

WHAT WILL CHANGE AFTER THE MERGER?

For MS Amlin Marine NV, only the name will change on July 1st. The legal entity of MSIG Specialty Marine NV (former MSAM) will remain the same, operating under the existing regulatory authorisation issued by the Financial Services and Markets Authority. The registration number in the Belgian Cross Road Bank of Enterprises 670 726 393 also remains unchanged, as well as the applicable VAT number.

The global ultimate parent, MS&AD Insurance Group Holdings, Inc., stock listed in Tokyo and Nagoya (Japan) and the ownership structure will not change.

WHAT DOES THIS MEAN FOR YOU AS OUR PARTNER?

While the merger will require some administrative updates, they will be minimal:

- **Company name:** Our company name, **MSIG Specialty Marine NV** (former MSAM), will need to be updated on all relevant materials (e.g., website, relevant documents) by July 1st.
- Please ensure that the name **MS AISE** is updated to **MSIG Europe SE** across all MS Amlin Marine related documents and systems, where mentioned and applicable.
- **Company logo:** Our company logo will also need to be updated accordingly by July 1st. You can find our future corporate logo in the email that we sent earlier, as well as below.
