WHO European Region preparatory meetings for the eleventh session of the Conference of the Parties (COP11) to the WHO FCTC and the fourth session of the Meeting of the Parties (MOP4) to the Protocol to Eliminate Illicit Trade in Tobacco Products

I have the honour to inform you that the WHO Regional Office for Europe, together with the Secretariat of the WHO Framework Convention on Tobacco Control (WHO FCTC), plans to hold preparatory meetings for the eleventh session of the Conference of the Parties (COP11) and the fourth session of the Meeting of the Parties (MOP4) to the Protocol to Eliminate Illicit Trade in Tobacco Products in the WHO European Region. These meetings will be held virtually (through Zoom) in October 2025 on the following days:

The objective of the COP11 and MOP4 preparatory meetings is to provide an opportunity for Parties to be briefed about agenda items and to clarify areas in which they might have questions.

The working languages will be English and Russian, and simultaneous interpretation will be provided. The provisional agendas for both events are enclosed.
