The aim of the seminar is to take a practical approach to strengthening the process of transferring sentenced persons by improving the cooperation between national experts, encourage networking and find ways to simplify the transfer. By bringing national experts together we hope to find solutions to mutual problems concerning matters of transfer of sentenced persons, as well as sharing tools and knowledge to rationalise the process of transferring such persons abroad. The bulk of the seminar will be devoted to workshops.
