Dear Stephanie,

I would like to clarify the amendment of the National Programme in regard to additional allocations for ISF Borders and Visa. The allocation for Estonia in total is **1 581 191**.

The note **AMIF/ISF/2017/20** states that „the financial allocations have to be earmarked as such in the national programmes of each Member State and are to be used to achieve specific actions to be established in the light of the priorities of the Union“ based on the Regulation (EU) No 515/2014 Art. 8 (6). Art 8 (6) states that „ .....Member States may receive an additional allocation, provided that it is earmarked as such in the national programme and is to be used to achieve specific actions to be established in the light of the priorities of the Union at that time“.

**In the light of what is mentioned above, I would like to ask:**

- What does it exactly mean that the allocations have to be **earmarked** as such in the national programmes of each MS and are to be used to achieve specific actions to be established in the light of the priorities of the Union? Does it mean that we must take into consideration the main developments in Union policies that were outlined in the note enclosed to the communication AMIF-ISF/2017/14 (Ares(2017)3297389 Developments in Union Policies) and basically choose an EU policy development from that letter to where we would like to spend the additional allocation and change our NP accordingly? For example if we want to use our additional allocation to Entry-Exit system, then we have to change the text in our NP accordingly?

- Or would it be enough, if we would just add the additional allocation to our National Programme financial plan?

Another issue is that there seems to be a problem in SFC. I cannot **create new programme**. It doesn't show the CCI number and when I click to the „request a new CCI number“ it doesn't really do anything. What could be the problem?
