The Ministry of Health of Ukraine extends its sincere gratitude for your sustained partnership and steadfast support of our national healthcare system. Your dedication to humanitarian values and access to essential medical care has been instrumental in preserving lives under the extraordinary strain of war.

As Ukraine continues to endure the devastating consequences of full-scale military aggression, the country's health infrastructure is being pushed to its limits. The destruction of medical facilities, internal displacement of the population, and sustained pressure on healthcare professionals have all contributed to a significant disruption in the delivery of care. This pressure, disrupted logistics, have led to critical deficits in essential medical supplies across all regions.

A matter of urgent concern is the growing shortage of medicines for the treatment of cancer in both children and adults. Oncology patients require highly specialized, uninterrupted care, and even short delays in access to medication can lead to irreversible health consequences. In response to this acute need, we are appealing to your organization for humanitarian assistance in the form of oncology medicines and related supplies. These resources will be vital in supporting cancer care continuity, mitigating treatment interruptions, and protecting the most vulnerable patients from preventable complications and fatal outcomes.

An annex detailing priority medicines is enclosed for your consideration. We remain at your disposal to coordinate logistics, provide technical details, and facilitate any necessary formalities to ensure the timely and effective delivery of aid.
