# APPLICATION PROCEDURE

TIHTC encourages applicants to apply as early as possible and make sure all documentation is in order before submission. Applications for Emergency Care and Burn Injuries Management project training should be submitted before Sep 14<sup>th</sup>.

## 1 Supporting documents preparation

- CV, passport copy, medical reports (Chest X-ray, Hepatitis B, syphilis, measles, rubella, etc.), ID photo, recommendation letter, diploma, English certificate, etc.

## 2 Fill out the online application form and upload supporting documents

- In case of missing documents, the applicant is required to submit them within 2 weeks of receiving notice, otherwise the application will be considered invalid and may be rejected.



## 3 Application review

- Application reviews are conducted jointly by TIHTC and the Ministry of Health and Welfare. It may take 2~3 weeks for the review.
- Other supplementary documents may be required at this stage.

## 4 Acceptance

- Upon receiving the final results of your application from the MOHW, TIHTC will notify applicants via email and send the official acceptance letter.
