Many feel that the social contract is fractured or benefits others more than them. Healing it must start with health, a sector uniquely positioned to restore trust and solidarity. In these uncertain times, safeguarding European values rooted in a strong social contract is more urgent than ever.

The EHFG annually convenes around 1700 participants onsite and online for candid exchange and active collaboration, comprising senior decision-makers as well as key experts and community members from government and administration, business and industry, civil society, and science and academia.
