#### Notes to Appendix 12-A-1

1. The contracting authorities of Member States of the European Union cover any subordinated entity of those contracting authorities provided it does not have separate legal personality.
2. Procurement by entities in the field of defence and security is only covered with regard to non-sensitive and non-warlike materials listed in Appendix 12-A-4.
3. Article 12.25 shall not apply to suppliers and service providers of Argentina referred to in Note 1 of Appendix 12-B-7, regarding the award of contracts in the European Union to suppliers or service providers of Signatory MERCOSUR States other than Argentina which are small or medium-sized enterprises<sup>1</sup> under the law of the European Union until the European Union accepts that Argentina no longer operates differential measures in favour of domestic small and medium-sized enterprises.

<sup>1</sup> The European Union may define the characteristics of the companies that will be considered SMEs taking into account the specificities of its different Member States, sectors and regions and based on one, some or all of the following attributes or their equivalents: employed or occupied personnel, annual sales value and value of assets applied to the production process, amongst others, in accordance with European Union legislation. These characteristics shall be defined in the European Union's general laws and regulations, including at the level of the Member States of the European Union and not in any law or regulation which exclusively applies to government procurement.

## Notes to Appendix 12-A-5

1. Procurement by procuring entities listed in Appendices 12-A-1, 12-A-2 and 12-A-3 of any of the services covered under this Appendix is a covered procurement with regard to MERCOSUR's provider of service only to the extent that MERCOSUR has covered that service under Appendices 12-B-5, 12-C-5, 12-D-5 or 12-E-5, respectively.
2. Chapter 12 does not apply to services which entities have to procure from another entity pursuant to an exclusive right established by a published law, regulation or administrative provision.
3. With regard to banking and investment services, Chapter 12 does not apply to the procurement or acquisition of fiscal agency or depository services, liquidation, and management services for regulated financial institutions or services related to the sale, redemption and distribution of public debt, including loans and government bonds, notes and other securities.

In Sweden, payments to and from governmental agencies shall be transacted through the Swedish Postal Giro System (Postgiro).

**CONSTRUCTION SERVICES AND WORKS CONCESSIONS**

**A. Construction services:**

1. Subject to the General Notes in Appendix 12-A-7, Chapter 12 covers all construction services listed in Division 51 of the Provisional Central Product Classification procured by procuring entities specified in Appendices 12-A-1 to 12-A-3.
2. A "construction services contract" means a contract which has as its objective the realisation by whatever means of civil or building works, in the sense of Division 51 of the CPC.
3. Procurement by procuring entities listed under Appendices 12-A-1 to 12-A-3 of any of the construction services covered under Appendix 12-A-6 is a covered procurement with regard to a Signatory MERCOSUR State's provider of a construction service only to the extent that the Signatory MERCOSUR State concerned has covered that construction service under Appendices 12-B-6, 12-C-6, 12-D-6 or 12-E-6, respectively.

**B. Works concessions:**

1. Works concessions contracts awarded by procuring entities specified in Appendix 12-A-1 shall be subject to Articles 12.6 and 12.11 limited to the construction services providers of Argentina and Brazil, provided their value equals or exceeds 5 000 000 (five million) SDRs.

2. For the purposes of this Appendix, a "works concessions contract" means a contract for pecuniary interest concluded in writing by means of which procuring entities entrust the execution of works to one or more economic operators the consideration for which consists either solely in the right to exploit the works that are the subject of the contract or in that right together with payment. The award of a works concession shall involve the transfer to the economic operators of an operating risk in exploiting those works encompassing demand or supply risk or both. The recoup of the investments made or the costs incurred in operating the works should not be guaranteed.



GENERAL NOTES

1. The following Notes shall apply:
  - (a) Chapter 12 shall not apply to procurement of agricultural products made in furtherance of agricultural support programmes and human feeding programmes (for example, food aid including urgent relief aid);

- (ii) From the 6<sup>th</sup> (sixth) year after the date of entry into force of this Agreement onwards:  
SDR 5 000 000 (five million).

## SUB-CENTRAL GOVERNMENT ENTITIES

Argentina shall initiate internal consultation proceedings with its provincial governments and the government of the Autonomous City of Buenos Aires, with a view to committing a satisfactory level of coverage at sub-central level. Consultations shall be conducted with the aim of engaging all the entities under such sub-central governments. Coverage shall be considered satisfactory if it encompasses sub-central governments which generate at least 65 % (sixty-five percent) of its national GDP<sup>1</sup>.

Argentina shall conclude these consultations no later than 2 (two) years after the date of entry into force of this Agreement and shall immediately notify the European Union of the results of such consultations.

Provided that the satisfactory coverage set out under the first paragraph of this Appendix has been achieved, the Trade Council shall adopt a decision to modify this Appendix accordingly.

If consultations at sub-central level do not lead to a satisfactory outcome within the stipulated timeframe, the European Union and Argentina shall consult with a view to assessing the consequences for Chapter 12.

## CONSTRUCTION SERVICES AND WORKS CONCESSIONS

### 1. CONSTRUCTION SERVICES

Subject to the Notes to this Appendix and the General Notes in Appendix 12-B-7, Chapter 12 covers all government procurement of construction services listed in Division 51 of the Provisional Central Product Classification carried out by the Argentinian entities listed in Appendix 12-B-1.

### 2. WORKS CONCESSIONS

When awarded by entities listed in Appendix 12-B-1 and subject to the thresholds applicable to construction services contracts as specified in Appendix 12-B-1, the only articles of Chapter 12 that apply to works concessions contracts are Article 12.6 and Article 12.11.

For the purposes of this paragraph, works concessions contracts means any contractual agreement the main objective of which is to undertake the construction or rehabilitation of physical infrastructure, plants, buildings, facilities, or other government-owned works and under which a procuring entity grants to a supplier, through a contract and for a specified period of time, the temporary ownership or the right to control, operate and demand payment for the use of those works for the duration of the contract.

Note to Appendix 12-B-6:

For procurement contracts of goods in connection with a contract of construction services, including works concessions contracts, Argentina reserves the right to apply price preferences according to its law for the following goods, expressed in the Harmonized System (HS), for the following transitional periods:

- HS 8410<sup>1</sup> and HS 8504<sup>2</sup>: from the date of entry into force of this Agreement until the end of the 9<sup>th</sup> (ninth) year after the date of entry into force; as of the 10<sup>th</sup> (tenth) year after the date of entry into force of this Agreement no price preference shall be applied; and
- HS 8414<sup>3</sup> and HS 8428<sup>4</sup>: from the date of entry into force of this Agreement until the end of the 4<sup>th</sup> (fourth) year after the date of entry into force; as of the 5<sup>th</sup> (fifth) year after the date of entry into force of this Agreement no price preference shall be applied.

## GENERAL NOTES

The following general notes apply to Chapter 12:

1. Chapter 12 shall not apply to any form of preference or advantage aimed at SMEs<sup>1</sup>. The preference or advantage may include any price preference, the right to improve the original tender, or the exclusive right to provide a good or service. Access to the above-mentioned preferences or advantages will be equally available to enterprises of the European Union registered as micro, small and medium-sized enterprises in Argentina. For greater certainty, enterprises of the European Union can register as micro, small and medium-sized enterprises in Argentina in accordance with the requirements set out in the relevant applicable law.
2. Chapter 12 does not apply to pre-commercial government procurement aimed at promoting the development of innovative solutions for public sector needs. Pre-commercial government procurement includes the product idea, solution design, prototyping, original development and validation or testing of a limited set of first products.

Every 3 (three) years after the date of entry into force of this Agreement, Argentina shall inform the European Union about the pre-commercial government procurement carried out during that period.

<sup>1</sup> For greater certainty, SMEs includes micro, small and medium-sized enterprises and entrepreneurs. Argentina may define the characteristics of the companies that will be considered SMEs taking into account the specificities of the different sizes, sectors and regions of the country and based on one, some or all of the following attributes or their equivalents: employed or occupied personnel, annual sales value and value of assets applied to the production process, amongst others, in accordance with its national legislation. These characteristics shall be defined in Argentina's general laws and regulations and not in any law or regulation which exclusively applies to government procurement.

3. Chapter 12 does not apply to concessions of services.
4. Chapter 12 does not apply to public procurement of goods and services from productive establishments of family farmers or family farmers cooperatives registered in a Family Farmer National Registry carried out by the national government for the provision of food in hospitals, schools, community canteens, institutions under the national penitentiary system, armed forces and other public institutions under the national government.
5. Notwithstanding Article 12.14(5), Argentina may exclude a supplier if:
  - (a) there is a confirmed indictment against the supplier for crimes against property, or against the public administration, or against public trust and good faith, or asset laundering or other financial crimes, or for crimes set out in the Inter-American Convention against Corruption, adopted at the third plenary session, held on March 29, 1996; or
  - (b) the supplier is:
    - (i) an agent or official of Argentinian public sector; or
    - (ii) an enterprise in which such agent or official has sufficient participation so as to control the enterprise's decision-making process.

For greater certainty, in procurements under the public-private partnership regime, the reference to bankruptcy in subparagraph (a) of Article 12.14(5) includes an ongoing insolvency proceeding.

6. Argentina reserves the right to award contracts by means other than open or selective tendering procedures in the following cases:
- (a) procurement undertaken for the repair of machinery, vehicles, equipment or engines whose disarmament, transfer or prior examination is essential to determine the necessary repair and the adoption of another contracting procedure will prove to be more expensive; this exception may not be used for common maintenance repairs of such items;
  - (b) government procurement undertaken between jurisdictions and entities of the national government, or between such jurisdictions and entities and provincial or municipal entities or entities of the Government of the Autonomous City of Buenos Aires, as well as with enterprises in which Argentina has majority participation, provided that the purpose of the procurement is the provision of security, logistics or health services;
  - (c) government procurement undertaken between jurisdictions and entities of the national government and national universities; and
  - (d) for complementary works that are essential for the execution of an ongoing public work (construction services), which could not have been foreseen in the original project and could not be included in the respective contract; the value of the contracts awarded for such complementary works shall not exceed the limits set by Argentina's law, which shall in no case exceed 50 % (fifty percent) of the value of the main contract.
7. Chapter 12 does not apply to government procurement carried out outside the territory of Argentina for consumption outside that territory.



8. Notwithstanding Article 12.11 (Offsets), when the entities listed in Appendix 12-B-1 carry out government procurement covered by Chapter 12, Argentina may seek or impose, in accordance with its law, any type of offset for up to 50 % (fifty percent) of the value of the procurement, including that the awarded supplier purchases local goods and services related to the object of the procurement.

From the 11<sup>th</sup> (eleventh) year to the end of the 15<sup>th</sup> (fifteenth) year after the date of entry into force of this Agreement, Argentina may only seek or impose offsets for up to 35 % (thirty five percent) of the value of the procurement.

The limitations set out in the first and second subparagraphs of this paragraph shall not apply to procurements undertaken by the Ministerio de seguridad or the Ministerio de defensa.

From the 16<sup>th</sup> (sixteenth) year after the date of entry into force of this Agreement offsets shall not exceed 20% (twenty percent) of the value of the procurement.

Offsets shall be indicated in the notice of intended procurement, shall be specified in the tender documentation and shall be applied in the same manner among all participating suppliers.

Every 3 (three) years from the date of entry into force of this Agreement, Argentina shall inform the European Union about the use of offsets carried out during that period.

9. Notwithstanding Article 12.13(1), for procurement entities covered under Appendix 12-B-1, Argentina may apply a transitional period of up to 18 (eighteen) months from the date of entry into force of this Agreement. Those entities shall, during such transitional period, provide their notices of intended procurement through links in a gateway electronic site that is accessible free of charge.

## GENERAL NOTES

Unless otherwise specified, the following general notes apply to Chapter 12:

1. Chapter 12 does not apply to:
  - (a) procurement made outside the territory of Brazil for consumption outside the territory of that Party;
  - (b) contracting related to the delegation of services, such as authorizations, permits, and concessions, except for the concessions of works which are covered under Heading 2 of Appendix 12-C-6;
  - (c) public procurement of goods and services purchased under food and nutritional security and school feeding programmes that support family farmers or family farming cooperatives carrying specific registration, according to Brazil's laws and regulations;
  - (d) procurement related to the Unified Health System (SUS).
2. The prohibition of offsets outlined in Article 12.11 shall not apply to Brazil if the conditions and their assessment are non-discriminatory among potential tenderers, clearly defined in the procurement documents and indicated in the notice of intended procurement.
3. Brazil reserves the right to apply margins of preference to national manufactured goods and services as established in the federal Brazilian legislation. The European Union shall be informed within 30 (thirty) days after the government takes a decision regarding goods and services that may fall under this category.

4. Brazil reserves the right to apply margins of preference in prices, as well as set-aside policies of up to 25 % of the procurement object, in favor of its micro and small enterprises<sup>1</sup>.
5. Brazil reserves the right to conduct a limited tendering procedure in procuring goods and services from non-profit Brazilian institutions dedicated to social assistance, public services, or social services of public interest.
6. In addition to the possibility to conduct limited tendering for pre-commercial government procurement aimed at promoting the development of innovative solutions for public sector needs set forth in point (e) of Article 12.20(1), Brazil may, whenever this provision has been invoked, use limited tendering for subsequent purchases of the same goods and services that have been developed under such arrangement from the national developer of the prototype or first good or service.
7. Article 12.13(2) shall be applied by Brazil 3 (three) years after the date of entry into force of this Agreement.

A small business is defined as a legal entity or sole proprietorship with annual gross revenue between R\$ 244,000.00 and R\$ 1,200,000.00. These limits are calculated proportionally in the first year of operation. NOTE ON THE APPLICATION OF ANNEX 12-D  
BETWEEN THE EUROPEAN UNION AND PARAGUAY

Application of Annex 12-D of Paraguay shall be subject to receipt by the European Union within 3 (three) years after the date of entry into force of this Agreement of a written notification by Paraguay stating the consent of Paraguay to apply the said Annex no later than (three) years after date of entry into force of this Agreement.

## GENERAL NOTES

The following general notes apply to Chapter 12.

1. In the national public tenders called by the entities covered by Appendices 12-D-1- and 12-D-2, Paraguay reserves the right to apply support programmes for the production and employment on the basis of contracts concluded by the Paraguayan State. With regard to support programmes for production and national employment, Paraguay may:
  - (a) for 18 (eighteen) years as of the date of entry into force of this Agreement, apply a margin of price preferences of 20 % (twenty percent), to products and services of national origin:
    - (i) in products, when labour, raw materials and inputs from Paraguay represent a percentage equal to or greater than 40 % (forty percent); and
    - (ii) in road works, constructions, maintenance services, transportation, insurance, consulting and others in general when more than 70 % (seventy percent) of the staff of the provider is of Paraguayan nationality;
  - (b) for 10 (ten) years as of the date of entry into force of this Agreement, use support programmes to stimulate innovation and scientific and technological research, including offsets provided that their conditions and their assessment are non-discriminatory and indicated in the notice of intended procurement and clearly defined in the procurement documents;

2. Chapter 12 shall not apply when the subject matter of the bidding refers to national policies aimed at: education, services for public health included in programmes approved by the Ministry of Health, food and nutritional security and school feeding programmes, and family farming programmes, according to Paraguayan law.
3. Chapter 12 does not apply to:
  - (a) purchases of state owned and any other public institutions not listed in Appendices 12-D-1 and 12-D-2 of Paraguay;
  - (b) contracts for the delegation of services, such as authorisations, permits and concessions, including the concession of public works;
  - (c) non-contractual agreements or any form of assistance provided by a Party or by a state owned enterprise, including contracting under programmes financed with loans from international financial organisations, donations, capital increases, tax incentives, subsidies, guarantees, agreements, cooperation and public provision of goods and services to people or governments at the regional, province or local level;
  - (d) contracts signed for the sole purpose of rendering foreign assistance;
  - (e) public procurement made outside the territory of the Party, for consumption outside the territory of the Party;
  - (f) the acquisition of services of agencies or services of tax warehouses, services of liquidation and administration for regulated financial institutions, nor the services of sale and distribution of public debt; or

- (g) public procurement undertaken among public entities, whether they are included or not in Appendix 12-D-1, as long as the object of the contract is not subcontracted to a third person that is not a public entity and provided that the object of the contract refers to logistics, social and educational goods and services.

  - (f) the contracts made within the framework of the Public Procurement for Development Programme and the law on family farming and artisanal fishing;
  - (g) the acquisition of services of agencies or services of fiscal deposits, services of liquidation and administration for regulated financial institutions, nor the services of sale and distribution of public debt;

- (h) public procurement by an entity to another entity or company of the State of Uruguay, whether or not listed in Appendices 12-E-1, 12-E-2 and 12-E-3.
  - (i) the hiring of non-profit institutions dedicated to social assistance, teaching, research and institutional development; or
  - (j) public procurement made outside the territory of Uruguay, for consumption outside the territory of the Party.
2. Notwithstanding any provision of this Agreement, in construction services contracts or public works, Uruguay may grant a margin of preference in the price of the offers, which may be conditioned to hiring nationals, in accordance with the requirements of qualification established in Uruguayan law.

This condition shall be indicated in the notice of intended procurement and clearly defined in the tender documentation;

## Exceptions to the public tender procedure

Entities may award contracts by means other than the open tender procedures, in the following cases:

- (a) in the case of construction services or public works, when construction services additional to those originally contracted are required, in order to respond to unforeseen circumstances and that are necessary to fulfil the objectives of the contract on which they are based; the total value of the contracts awarded for such additional construction or public works services may not exceed 50% (fifty percent) of the amount of the main contract; and
  - (b) when an entity requires consulting services related to matters of a confidential nature the disclosure of which could reasonably be expected to prejudice confidential information of the public sector, cause serious economic disturbances or, otherwise, be contrary to the public interest.

**NOTICE INVITING INTERESTED SUPPLIERS  
TO APPLY FOR INCLUSION IN A MULTI-USE LIST**

Each notice inviting interested suppliers to apply for inclusion in a multi-use list shall include:

- (a) a description of the goods or services, or categories thereof, for which the list may be used;
- (b) the conditions for participation to be satisfied by suppliers for inclusion on the list and the methods that the procuring entity will use to verify that a supplier satisfies the conditions;
- (c) the name and address of the procuring entity and other information necessary to contact the entity and obtain all relevant documents relating to the list;
- (d) the period of validity of the list and the means for its renewal or termination, or where the period of validity is not provided, an indication of the method by which the termination of use of the list is to be notified; and
- (e) an indication that the list may be used for procurement covered by Chapter 12.

---

## TIME PERIODS

Deadline for the submission of requests for participation in the case of selective tendering

1. A procuring entity that uses selective tendering shall establish that the final date for the submission of requests for participation shall not, in principle, be less than 25 (twenty-five) days from the date of publication of the notice of intended procurement. Where a state of urgency duly substantiated by the procuring entity renders this time period impracticable, the time period may be reduced to no less than 10 (ten) days.

Deadlines for the submission of tenders

2. Except as provided for in paragraphs 3, 4, 6 and 7, a procuring entity shall establish that the final date for the submission of tenders shall not be less than 40 (forty) days from the date on which:
  - (a) in the case of open tendering, the notice of intended procurement is published; or
  - (b) in the case of selective tendering, the entity notifies suppliers that they will be invited to submit tenders, whether or not it uses a multi-use list.

Cases for which the time period for tendering (open and selective) can be reduced

3. A procuring entity may reduce the time period for tendering set out in paragraph 2 to not less than 10 (ten) days where:
  - (a) the procuring entity published a notice of planned procurement under Article 12.13 (3) at least 40 (forty) days and not more than 12 (twelve) months in advance of the publication of the notice of intended procurement, and the notice of planned procurement contains:
    - (i) a description of the procurement;
    - (ii) the approximate final dates for the submission of tenders or requests for participation;
    - (iii) the address from which documents relating to the procurement may be obtained; and
    - (iv) as much of the information that is required under Annex 12-O for the notice of intended procurement, as is available;
  - (b) the procuring entity, for procurements of a recurring nature, indicates in an initial notice of intended procurement that subsequent notices will provide time periods for tendering in accordance with this paragraph; or
  - (c) a state of urgency duly substantiated by the procuring entity renders the time period for tendering established in accordance with paragraph 2 impracticable.

4. A procuring entity may reduce the time period for tendering set out in paragraph 2 by 5 (five) days for each one of the following circumstances:
  - (a) the notice of intended procurement is published by electronic means;
  - (b) all the tender documentation is made available by electronic means on the date of the publication of the notice of intended procurement; and
  - (c) the tenders can be received by electronic means by the procuring entity.
5. The use of paragraph 4, in conjunction with paragraph 3, shall in no case result in the reduction of the time period for tendering set out in paragraph 2 to less than 10 (ten) days from the date on which the notice of intended procurement is published.
6. Notwithstanding any other provision in this Annex, where a procuring entity purchases commercial goods or services, or any combination thereof, it may reduce the time period for tendering set out in paragraph 2 to:
  - (a) no less than 13 (thirteen) days, provided that it publishes by electronic means, at the same time, both the notice of intended procurement and the tender documentation; and
  - (b) no less than 10 (ten) days, if the entity also accepts tenders for commercial goods or services by electronic means.
7. Where a procuring entity listed in Appendices 12-A-2, 12-A-3, 12-B-2, 12-B-3, 12-C-2, 12-C-3, 12-D-2, 12-D-3, 12-E-2 and 12-E-3 has selected all or a limited number of qualified suppliers, the time period for tendering may be fixed by mutual agreement between the procuring entity and the selected suppliers. In the absence of agreement, the period shall not be less than 10 (ten) days.



## THRESHOLDS ADJUSTMENT FORMULA

For the European Union:

- (a) The threshold shall be adjusted at 2 (two)-year intervals with each adjustment taking effect on 1 January;
- (b) The calculation of the values of thresholds shall be based on the average of the daily values of the special drawing rights (hereinafter referred to as "SDRs") to Euro exchange rate over the 24 (twenty-four) months terminating on 31 August preceding the revision with effect as of 1 January. The value of the thresholds thus revised shall, if necessary, be rounded down to the nearest thousand Euros. The data source for the exchange rate is the International Monetary Fund (hereinafter referred to as "IMF"); and
- (c) The value of the newly calculated thresholds shall be made publicly available by the European Union before the respective thresholds take effect.

For Signatory MERCOSUR States:

- (a) Each Signatory MERCOSUR State shall calculate and convert the value of the thresholds into its national currency, using the conversion rates of the IMF. The conversion rates shall be the average of the values of their respective national currencies in terms of the SDR published by the IMF in its monthly "International Financial Statistics", over the 2 (two)-year period preceding 1 October of the year prior to the thresholds becoming effective. The converted thresholds shall apply as of 1 January of the following year and shall be fixed for 1 (one) year; and

- (b) The value of the newly calculated thresholds shall be made publicly available by each of the Signatory MERCOSUR States, in its national currency, before the respective thresholds take effect.

## NOTICE OF INTENDED PROCUREMENT

Each notice of intended procurement shall include:

- (a) the name and address of the procuring entity and other information necessary to contact the procuring entity in order to obtain all relevant documents relating to the procurement, and their cost and terms of payment, if any;
- (b) a description of the covered procurement, including the nature and quantity of the goods or services to be procured or, where the quantity is not known, the estimated quantity;
- (c) the procurement method to be used and whether it involves negotiation or electronic auction;
- (d) the address and final date for the submission of tenders;
- (e) the language or languages in which tenders or requests for participation may be submitted, if they may be submitted in a language other than an official language of the Party of the procuring entity;
- (f) for recurring contracts, if possible, an estimate of the timing of subsequent notices of intended procurement;

- (g) a description of any options;
  - (h) the timeframe for delivery of goods or services or the duration of the contract;
  - (i) where applicable, the address and any final date for the submission of requests for participation in the procurement;
  - (j) a list and brief description of any conditions for participation of suppliers; and
  - (k) where, pursuant to Article 12.15, a procuring entity intends to select a limited number of qualified suppliers to be invited to tender, the criteria to be used to select them and, where applicable, any limitation on the number of suppliers permitted to tender.
