Annual status update (ASU) on measles and rubella elimination for 2025

We are pleased to inform you that the 15th meeting of the European Regional Verification Commission for Measles and Rubella Elimination (RVC) is planned to take place in September of 2026. The aim of the meeting is to review the status and achievements towards measles and rubella elimination in Member States and in the Region as a whole.

All Member States are requested to submit their completed annual status update on measles and rubella elimination (ASU) for the year 2025 by 30 June 2026. An ASU form for 2025 and relevant documents should be submitted to the WHO Regional Office for Europe (RVC Secretariat) by e-mail (eurvc@who.int).

Attached to this e-mail you can find a template for the 2025 ASU and an Excel file with pre-prepared tables and formulas to help with calculating data. It is important to ensure that ASUs are prepared with national technical experts and approved by the respective national verification committee (NVC), as their independent review is critical for the verification process. NVC's review should be based on accurate data, consistent with other national data routinely submitted to the Regional Office, and other information that is not routinely provided in monthly and annual reporting to WHO.

The RVC and its Secretariat are committed to providing you with any support that you may require. We would like to stress that your efforts in documenting the absence of endemic transmission in your country are highly appreciated and critical to achieving measles and rubella elimination in the Region.
