Re: Integration of webMethods and StreamSets businesses into IBM and associated operational changes

Dear Customer or Partner:

Previously, you were contacted by Software AG ("SAG") regarding IBM's acquisition of their webMethods (including EntireX and ApplinX) and StreamSets platforms. As part of, and to facilitate, this transaction, SAG contract(s) for the webMethods offerings and services were assigned or, in some cases, partially assigned and transferred, to an integration company as set forth in the communication from SAG (Super iPaaS, "Integration Company"). StreamSets Inc. contracts remained with StreamSets Inc.

While the Integration Company and StreamSets Inc. became indirect wholly-owned subsidiaries of IBM upon the close of this transaction in your jurisdiction, IBM has continued working towards its goal of fully integrating the webMethods and StreamSets platforms and their associated businesses into our company and will soon reach an important milestone in this process.

On 1 January 2025, Integration Company and StreamSets Inc. business operations will be transferred to IBM and, going forward, the Integration Company and StreamSets Inc. will conduct business as IBM Corporation and its affiliates (collectively, "IBM"). On or around this date, the rights and obligations arising under your active Integration Company and/or StreamSets Inc. order forms, SOWs, or other transaction documents (your "contract(s)") for the webMethods and/or StreamSets offerings and services, including their associated back-office activities, will be assigned and/or transferred in their entirety to the IBM affiliate as further set out in the Appendix to this letter.

As Integration Company and StreamSets Inc. business processes and systems are replaced by IBM business processes and systems, there will be changes to operational activities associated with these contract(s), such as billing and payments. To help prepare webMethods and StreamSets customers for this transition, we have created a "Doing Business with IBM" guide which can be accessed at https://ibm.biz/wMandSX. Please review the details provided in this document and kindly share with the appropriate individual(s) in your company.
