Visit to ZGH Bolesław in Olkusz – Recovery of raw materials from mining waste and other industrial waste

Participants will have the opportunity to visit ZGH Bolesław in Olkusz, where the focus will be on the recovery of valuable zinc raw materials from tailings (flotation waste), steel dust and other industrial waste. This visit will highlight the world class achievements regarding zinc raw materials production from industrial waste sources.

Visit to Elemental Strategic Metals in Zawiercie – Recovery of raw materials from batteries and catalysts.

Participants will also visit Elemental Strategic Metals, where the recovery of raw materials from batteries and catalysts will be presented. This tour will highlight good practices in sustainable resource management and the recycling of critical materials from end-of-life products.
