

ANNEX 2 OF THE PUBLIC CONTRACT NO 1.11-9/665-1

POLICE AND BORDER GUARD BOARD OF THE REPUBLIC OF ESTONIA, represented by the Deputy Director General in the field of property Mr. Tauno Tuisk, acting on the basis of the directive No 63 of the Director General (hereinafter – the Contracting Authority), on the one side,
and

OY HL-METAL AB and ARCTIC AIRBOATS LTD, represented by the joint tenderer Oy HL-Metal ab acting on the basis of the power of attorney board member Markus Flinkman, (hereinafter – the Contractor), on the other side,



separately also named a Party and jointly the Parties, have entered into this Annex 2 of the public contract No 1.11-9/665-1, 23.08.2016 (hereinafter – the Contract) in the following.

1. When entering into amendment of the Contract, the Parties proceed the following:

- 1.1 according to the clause 12.3 of the Contract and section 69 subsection 3 of the Public Procurement Act, the Parties may agree on the amendment of the Contract only if the amendment is caused by objective circumstances that the Contracting Authority could not foresee during the conclusion of the Contract and if, in the event of leaving the public contract unamended, the achievement of the purpose sought with the Contract would be fully or to a material extent in jeopardy;
- 1.2 the Contracting Authority noted in the technical specification that he desires trailer with 750 kg without brakes The Contracting Authority also foresaw the trailer weight in the technical specification, but in actual construction phase became evident that the weight of the motorboat will be approximately 850 kg, because of the amount of the equipment's and Mercury Pro engine and therefore the Parties have come to an agreement that the trailer 750 kg without brakes given in the tender shall be replaced with trailer 1250 kg with brakes, which can hold the motorboat with the equipment and Mercury Pro engine.
- 1.3 it is not a substantial amendment of the Contract, but by concluding present amendment of the Contract, the object of the Contract and its functionality will correspond better to the needs of the Contracting Authority and the properties of use are more favourable to the Contracting Authority;
- 1.4. the circumstances are objective as the Contracting Authority could not initially foresee the amendment and the need occurred actually in the course of construction of the motorboat;
- 1.5 present agreement does not result in any additional financial obligations and changes in payment of the contract price provided for in the Contract and Contracting Authority.

2. Considering circumstances mentioned above, the Parties agree in the following.

- 2.1 Object of the Contract additional equipment is trailer:
 - 2.1.1 Weight- 1250 kg with brakes.

- 2.2 Other technical data of the Contract remain the same. The Contractor obliges to ensure that the terms on the functionality and the features of the trailer 750 kg given in the tender remain equivalent for the trailer 1250 kg.
- 2.3 Other terms of the Contract remain valid without amendments.

3. Other terms

- 3.1 Present agreement shall enter into as of the signing moment and is valid simultaneously with the Contract.



