Mul on hea meel kutsuda Teid teisele parlamentaarse demokraatia foorumile, mis toimub 29.–30. septembril 2026 Euroopa Parlamendis Brüsselis.

Esimene foorum, kus kutsuti üles jätkama parlamentaarset koostööd demokraatia kaitsmiseks ja kindlustamiseks pideva surve tingimustes, osutus väga edukaks. Tänavuse ürituse eesmärk on tagada, et hoog ei raueks.

Eelseisev parlamentaarse demokraatia foorum toob taas kokku liikmesriikide parlamentide ja Euroopa Parlamendi liikmed, peamiste parlamentaarsete võrgustike, kodanikuühiskonna ja noorteorganisatsioonide esindajad ning juhtivad eksperdid. Foorumil käsitletavate teemade hulgas on valimisprotsessiga seotud probleemidega toimetuleku võime suurendamine, parlamentaarse järelevalve tugevdamine, kodanikuühiskonna toetamine ja koordineerituma parlamentaarse diplomaatia väljatöötamine Euroopas.

Kirjale on lisatud päevakorra esialgne kavand. Teave osalemisega seotud praktiliste üksikasjade ja logistilise korralduse kohta edastatakse aegsasti Teie parlamendi Euroopa Parlamendiga suhtlemise eest vastutavale teenistusele.

Loodan väga, et Teie parlament osaleb sellel olulisel üritusel. Iga parlamenti võib esindada kuni kuus parlamendiliiget. Teie panus on väga tähtis, et rikastada arutelu ja tihendada parlamentide koostööd demokraatia kaitseks ja edendamiseks.

By showcasing national experiences and ongoing initiatives, the pre-session seeks to identify practical responses adapted to each country's electoral landscape and to foster mutual learning across the Union.*

**11:00 – 12:30 | European Democracy Shield - Protecting the safety of political candidates and elected representatives (with the Directorate-General for Justice and Consumers, European Commission)**

*Building on the discussions held during the 2025 EU Parliamentary Democracy Forum session on "Overcoming political polarisation", European and national parliamentarians will exchange views with the European Commission to inform the preparation of its forthcoming "Recommendation on safety in politics" and the dedicated "Guide of best practices", expected to be ready by the end of 2026.*

**15:00 – 16:30 | Session I: Mobilising a Whole-of-Society Approach to Safeguard Elections**

*This session will explore the main challenges facing elections across the EU and present the related proposals under the European Democracy Shield. It will examine how a whole-of-society approach to safeguarding elections can be put into practice. Participants will discuss the roles of parliaments, independent authorities, civil society and digital platforms in protecting electoral processes, as well as ways to strengthen citizens' engagement in elections.*

*The session will examine the EU Civil Society Strategy as a key instrument to reinforce democratic resilience across the Union. Finally, participants will consider how to embed meaningful and sustained participation of civil society in EU and national democratic decision-making, going beyond ad-hoc consultations.*
