I have the honour to inform you that, pursuant to the decision of the 34th Session of the General Assembly, the 2nd Extraordinary Session of the General Assembly of the International Centre for the Study of the Preservation and Restoration of Cultural Property (ICCROM) will be convened **online on 28 April 2026 at 12:30 (CEST), via Zoom platform.**

The session will be conducted in English, French, with simultaneous interpretation provided. Thanks to the generous financial contribution of the Government of Spain, in addition to the official working languages, Spanish interpretation will also be available during the Session.

The Secretariat is pleased to inform that the further detailed PWB 2026-2027 (detailed version) has been approved by consensus by the Council on 26 February 2026 and is available on the Governing Bodies portal in the three languages.

As agreed with the Council, Member States are invited to provide written comments, if any, within 15 days prior to the 2nd Extraordinary Session of the General Assembly, by midnight of Monday 13 April 2026, CEST.
