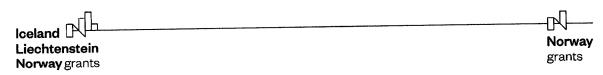


FINAL TECHNICAL ASSISTANCE REPORT FM14-21

Estonia



OVERVIEW OF MAIN ACTIVITIES

The main overall challenges during the whole implementation period were connected to the 2 crises in the world (travel restrictions, prices going up, troubles with supply chain, private enterprises focus on staying alive, state institutions focus on refugee crisis, hard to find donor partners etc). The main lesson learnt is that there are some things we cannot prevent from happening but there are ways to mitigate risks arising from these happenings. The main ways to mitigate risks is a good communication between all parties, openness to change and being solution oriented. And in Estonia we have managed well with effective communication and problem solving. One good example of a good communication is that we have had several reallocations (inside programmes, between programmes, from programmes to Bilateral Fund and Technical Assistance, from the reserve in Mou to Active Citizens Fund) during the implementation period and all parties have contributed a lot to help to maximise the effects of the Grants in that sense.

The National Focal Point (NFP) has the overall responsibility for the coordination and implementation of EEA and Norway Grants in Estonia. The NFP has been guiding Programme Operators (PO) throughout the implementation period and supporting them through the crisis in the world (Covid pandemic and war in Ukraine), monitoring the progress and quality of the implementation of programmes. The NFP has been participating in PO organised events, including Cooperation Committee and Selection Committee meetings, opening and closing events, project visits. The NFP has fulfilled its obligations regarding reporting (including Technical Assistance (TA) and Bilateral Fund Interim Financial Reports (IFRs), Strategic Reports) and organising Annual Meetings and other meetings with the donors.

The NFP is responsible for organising the Joint Committe for Bilateral Fund (JCBF) meetings and JCBF written procedures and coordinating bilateral fund initiatives - this part has been bigger and more challenging than expected. The budget of Bilateral Fund has increased over three times during the implementation period, thus increasing the workload. The two crisis in the world (Covid pandemic and war in Ukraine) have brought extra challenge to bilateral initiatives implementation (including activity plans modification, initiative period extension) but nevertheless all 68 initiatives finished their activities, only one partially. From the end of 2024 until the end of August 2025 the National Focal Point used additional workforce to coordinate Bilateral Fund initiatives. This was a great possibility to have even bigger impact with EEA and Norway Grants and use the surpluses from programmes successfully through Bilateral Fund initiatives. TA budget was modified due to that (reallocation in October 2024).

The NFP has been active with communication by being present in relevant media channels (including social media, TV, newspapers), conducting annual public awareness surveys, telling stories about successful projects, exchanging knowledge in workshops, organising three big events (including opening and final event). Cooperation with POs and Norwegian Embassy has had an important role in it.

The Certifying Authority (CA) is mainly responsible for checking and submitting IFRs and forecasts of likely payment applications. The CA has fulfilled its reporting obligations. In addition to that CA has guided POs, performed risk-based checks of TA and programme management costs, shared its knowledge through workshops and other events.

The Audit Authority (AA) is mainly responsible for carrying out management and control systems audits and project audits on the basis of their audit strategy. Overview of their work has been reported annually in Annual Audit Report. The AA has fulfilled its obligations, although it has been challenging for them. In 2024 and 2025 AA had to use additional workforce to fulfill the audit requirements. They had to perform more audits than foreseen initially. TA budget has been modified due to that (reallocation in January 2024 and October 2024). The work of AA continues, while all audits are not conducted and closure declaration needs to be submitted.

The Irregularities Authority (IA) is mainly responsible for checking and submitting irregularity reports. The IA has fulfilled its obligations. The work of IA continues, while all irregularities are not closed and all audits not conducted.

PROCUREMENT

Under Technical Assistance we have not procured anything above national thresholds for the procurement. Among smaller procurements there was event organization procured for the final event that took place on



12.12.2024, there has been IT support procured for Annual Meetings that could not happen face to face in 2020 and 2021, annual public awareness survey, annual best project clips for TV show etc. But these were all below the national thresholds for the procurement. We have used organisations (State Shared Service Centre and the Ministry of Finance) framework procurements for travelling and translations etc, but even these costs per procurement have fallen below the national thresholds for the procurement.

IRREGULARITIES

There has been only one irregularity case reported to the FMO regarding travel services procurement number 194541 (IR13 and IR14 in Grace). The value of the irregularity was EUR 356.08. The correction rate was 5% of the travel services and the amount of travel services was EUR 7121.64. State Shared Service Centre (SSSC) made the financial correction decision on 03/02/2020. All wrongfully paid amounts were recovered. According to Article 13.2.3 of the Regulation the budget of TA was not reduced. SSSC closed the case on 14/08/2020. FMO has also closed the case.

Additionally there have been 2 voluntary repayments regarding staff costs (no requirement to report to FMO).

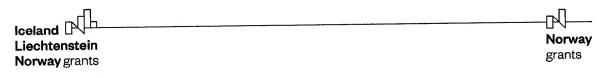

Overall implementation status (including milestones):

In 2025 the main focus has been on

- 1) coordinating the the Bilateral Fund JCBF meetings/procedures, guidance to initiatives, checking final reports/payments of initiatives,
- 2) finalising activities regarding 2014-21 period, including preparing and submitting the Final Programme Reports and the Final Strategic Report,
- 3) preparing for new programming period.

Altogether 68 programme and national level bilateral initiatives have been approved and 67 of them successfully ended, one ended with partial results. A large number of them, 32 initiatives were completed in 2025. We have witnessed strong motivation and great cooperation which is needed to implement initiatives successfully in short timeframe. When initially we were having difficulties with disbursements to initiatives then together with final efforts the disbursement rate of Bilateral Fund is 94%. NFP considers the implementation and the results of the Bilateral Fund good.

The NFP, CA and IA guided POs with closure related topics, including Final Programme Reports. Final Programme Reports were submitted on time, 30.04.2025 the latest. Final Strategic Report was submitted on 15.09.2025.

After successful MoU negotiations, the launching event of 2021-28 period took place on 27.05.2025. In the event the MoU-s, Technical Assistance Agreement and Bilateral Agreement were signed. Programme Operators had their Concept Note kick-off meetings and the preparation of programmes is now at full speed. The NFP attends all the Concept Note meetings and provides help to POs when needed.
