## 27th meeting of the Joint Convention/WHO Task Force on Health Aspects of Long-range Transboundary Air Pollution Bonn, Germany, 22-23 May 2024

The WHO Regional Office for Europe plans to hold the 27th meeting of the Joint Convention/WHO Task Force on the Health Aspects of Long-range Transboundary Air Pollution this May. Based on the nomination by your Government, we are pleased to invite you to participate.

The Secretariat in Bonn is organizing the meeting. The meeting will be attended by representatives of the Parties to the Convention and experts invited to present new research on air quality and health and the links to climate change. Participants will discuss updating of international policies and processes for air quality and health, experiences from Member States, including those related in implementation of the WHO global air quality guidelines and further developments in the WHO tools for assessing the health impacts of air pollution.
