世界卫生组织（世卫组织）谨向各会员国和准会员致意，并宣布药物依赖问题专家委员会第四十九次会议将于 **2026 年 10 月 19 日至 22 日** 在瑞士日内瓦举行。鉴于世卫组织专家委员会会议属于非公开会议，本函旨在向会员国通报这次会议的议程（载于附件一，供参考）。

1961 年和 1971 年《国际药物管制公约》授权世卫组织根据其独立科学咨询机构，即药物依赖问题专家委员会的建议，就精神活性物质国际管制的必要性和程度向联合国秘书长提出建议。为评估某种精神活性物质是否应受国际管制，药物依赖问题专家委员会每年召开会议，审查有关物质导致依赖、滥用和健康危害的可能性，以及任何治疗用途。为了进行审查并做出循证决策，药物依赖问题专家委员会利用现有最佳信息对选定的精神活性物质进行医学、科学和公共卫生评估。

虽然这些会议属于非公开性质，但仍邀请会员国和准会员参加 2026 年 10 月 19 日举行的药物依赖问题专家委员会第四十九次会议的信息通报会议，为药物依赖问题专家委员会的审查进程做出贡献。此次信息通报会议将以虚拟方式举行，旨在让有关各方了解药物依赖问题专家委员会秘书处当前和未来的活动，并向专家委员会第四十九次会议提交受审查物质的相关信息，供其审议。注册信息将适时公布在药物依赖问题专家委员会网站上：药物依赖问题专家委员会。

同过去一样，并根据《世卫组织审查受国际管制的精神活性物质指导方针》（EB126/2010/REC1，附件 6）¹这一出版物的要求，各会员国和准会员也可以通过在会议之前提供有关受审查物质的最新准确信息，为药物依赖问题专家委员会的审查进程做出贡献。为此，并按照以往惯例，将向会员国和准会员发送一份调查问卷，收集各国有关每种被评价物质的合法使用、有害使用、国家管制状况和国际管制的可能影响的信息。
