### **URGENT: Field Safety Notice**

**Subject:** Voluntary Product Recall – Wet n Wild Proline Felt Tip Eyeliner (E8752)

**Product Description:** Wet n Wild Proline Felt Tip Eyeliner

(hereinafter, the “**Product**”)

This is to inform you that Markwins Beauty Brands INTL Ltd is recalling the Product.

During an internal quality and regulatory review, a **non-conformity** was identified: the concentration of the color pigment **Carbon Black (CI 77266, nano)** in the Product exceeds the maximum permitted concentration of **10%** under **EU Cosmetic Regulation (EC) No 1223/2009 – Annex IV**, reaching 11.5%.
