Tenth edition of the WHO report on the global tobacco epidemic

The World Health Organization is committed to providing Member States with accurate, relevant, internationally comparable information to guide the development of health policy and to evaluate the impact of those policies. An example of this type of information source is the *WHO report on the global tobacco epidemic*, which WHO has published regularly since 2008.
