REQUIREMENTS SET OUT FOR THE TEAM MEMBERS (in English)

The tenderer must form a team consisting of at least three members from the following roles.

Team members must personally participate in fulfilling the procurement contract and simultaneously meet the specific requirements set for each role:

1. Project Manager:

- 1.1. Holds at least a higher education degree in Information Technology and Communication Technology or Economics or Business;
- 1.2. Holds at the time of submitting the tender an IT project management PMP or Prince 2 or ACP or equivalent certification;
- 1.3. Has, within the 60 months preceding the start of the public procurement, participated as a project manager in the fulfillment of at least two similar projects or contracts;

2. UI/UX Specialist:

2.1. Has, within the 60 months preceding the start of the public procurement, participated as a UI/UX specialist in the fulfillment of at least two similar projects or contracts;

3. Web Designer:

3.1. Has, within the 60 months preceding the start of the public procurement, participated as a web designer in the fulfillment of at least two similar projects or contracts;

4. Frontend Programmer:

4.1. Has, within the 60 months preceding the start of the public procurement, participated as a frontend programmer in the fulfillment of at least two similar projects or contracts;

5. Backend Programmer:

5.1. Has, within the 60 months preceding the start of the public procurement, participated as a backend programmer in the fulfillment of at least two similar projects or contracts;

6. Data Analyst:

6.1. Has, within the 60 months preceding the start of the public procurement, participated as a data analyst in the fulfillment of at least two similar projects or contracts;

7. Support Specialist (provides support after the website is published):

7.1. Has, within the 60 months preceding the start of the public procurement, participated as a support specialist in the fulfillment of at least two similar projects or contracts;

All team members must have the ability to communicate with the Contracting Authority in professional English.

The contracting authority shall consider web platform developments with a cost of at least 250,000 euros, which include data analysis and calculations based on user data, and have lasted at least 6 months, to be similar works. Previous experience gained through studies or internships shall not be considered as previous experience.

The tenderer submits information about the education, previous experience, and certification of team members on the form "Data on Team Members." The information must be sufficiently accurate and thorough for the contracting authority to assess the adequacy of the team members' education, certification and previous experience in accordance with requirements set in the procurement documents.

The tenderer shall submit copies of documents proving education and/or certification regarding the team members for whom requirements regarding education or certification have been set.

The contracting authority shall verify the compliance of the team members with the requirements based on the information provided in the tender. The contracting authority is entitled to verify the submitted data through publicly available databases. The contracting authority is entitled to request additional information from third parties to obtain further details. The contracting authority has the right to ask the tenderer for additional information and documents confirming the accuracy of the information provided in the form of confirmation. The tenderer submits the required data/documents requested by the procurer within 3 (three) working days.
