Expected results of the discussions:

1. Increased awareness among policymakers of the public value approach in health and welfare policy
2. Policy recommendations based on disease burden data in the Baltic States
3. Strengthened cooperation between the Baltic States in the use of data and access to health innovations
4. A roadmap for future steps to make health innovation a driver of economic growth
5. Emphasis on the link between health and security:
 - Physical and psychological health of conscripts as the foundation of national defence
 - Mother and child health as the cornerstone of demographic security
 - Health as a factor in long-term economic stability and national security

- How can the state balance its defence and health budgets, viewing health as part of security?
- Can investments in public health be as strategically important as military spending for long-term sustainability?
- How can health innovations help young people and conscripts maintain their physical and mental resilience?
