Alphametrics works for the European Institute for Gender Equality (EIGE) to update and maintain the data on women and men in decision-making published in . Please find attached a letter from the institute requesting your cooperation.

We are currently developing a methodology to collect and publish data on women and men in decision-making in sports organisations. The collection will cover organisations convened at both European and national levels (38 countries) and is restricted (for purposes of comparability) to organisations representing sports recognised by the International Olympic Committee. The data collected will be published in the EIGE database, input to the calculation of the social power domain in EIGEs , and may also be used in the context of the joint of the Council of Europe and European Commission concerning gender balance in sports organisations.
