In response to your letter dated 09 April 2021 with the above reference number, I sincerely apologise for the excessive delay in signing the grant agreement for and start of the project AMIF 2020-16. This delay is stemming both from the separation of the Head of IOM Estonia office in the beginning of 2021 and covering that function remotely from the IOM Finland office, and for seeking and coordinating internal endorsements and approvals within the Organization.

I am now pleased to confirm that we have received the approvals to sign the grant agreement. Similar to previous agreements, we will attach a cover letter to recognize the special status of IOM as a UN related organization. Kindly confirm if this confirmation by email is sufficient, or would you require a signed letter stating the same information.

in spite of multiple attempts to sign the document digitally using the Estonian ID-card software (DigiDoc4 client), I have not been able to complete the process successfully. This is due to a known software error in the current software version when using Finnish ID-cards with the Estonian ID-card system (<https://www.id.ee/en/article/known-id-software-defects/>). Therefore, we will have to sign the grant agreement in hard copy.
