Expected results of the discussions:

- 1. Increased awareness among policymakers of the public value approach in health and welfare policy
- 2. Policy recommendations based on disease burden data in the Baltic States
- 3. Strengthened cooperation between the Baltic States in the use of data and access to health innovations
- 4. A roadmap for future steps to make health innovation a driver of economic growth
- 5. Emphasis on the link between health and security:
 - Physical and psychological health of conscripts as the foundation of national defence
 - o Mother and child health as the cornerstone of demographic security
 - o Health as a factor in long-term economic stability and national security

Discussion questions for the audience:

- How can the state balance its defence and health budgets, viewing health as part of security?
- Can investments in public health be as strategically important as military spending for longterm sustainability?
- How can health innovations help young people and conscripts maintain their physical and mental resilience?
