Accession by Saint Kitts and Nevis

The Director General of the World Intellectual Property Organization (WIPO) presents his compliments and has the honor to notify the deposit by the Government of Saint Kitts and Nevis, on July 8, 2024, of its instrument of accession to the WIPO Copyright Treaty, adopted at Geneva on December 20, 1996.

The WIPO Copyright Treaty will enter into force, with respect to Saint Kitts and Nevis, on October 8, 2024.

WIPO Copyright Treaty

(Geneva, 1996)

In accordance with the Basic Law of Hong Kong, China, the Government of the People's Republic of China has decided that the Treaty will apply to Hong Kong, China with effect from October 1, 2008.

In accordance with the Basic Law of the Macao Special Administrative Region of the People's Republic of China (PRC), the Government of the PRC decides that the Treaty shall apply to the Macao Special Administrative Region. The declaration took effect on November 6, 2013.

⁴ The accession by New Zealand shall extend to Tokelau.

⁵ Serbia is the continuing State from Serbia and Montenegro as from June 3, 2006.

⁷ The United Kingdom extended the application of the Treaty to the territoriy of Gibraltar with effect from May 17, 2022.
