4. The names of nominees will be communicated by MIGA to your Governor on **Tuesday**, **June 4, 2024**, in order that the Governor may vote thereon. <u>However, if all Governors nominate</u> the same person and check the box to elect, then there will be no need to move to election and the checked nomination forms will serve as election ballots.
