Purpose: Our records indicate that we require updated U.S. tax forms for your account with Citibank Europe PLC. The requirement arises because your account is documented with a valid U.S. tax form that expires on December 31, 2025

Valid U.S. tax documentation is required for foreign persons to obtain a reduced rate or an exemption from U.S. withholding tax. In the absence of required U.S. tax documentation, we, as a withholding agent, must withhold a 30% U.S. tax from U.S. source income. In addition, the U.S. tax documentation may be necessary to establish an exemption from 24% backup withholding tax on foreign source income, gross proceeds from the sale of securities and U.S. source interest on short-term obligations or bank deposits.
