Your presence and participation at the IRENA Assembly is crucial as we work collectively towards a sustainable energy future and will be a powerful catalyst for collaboration and action towards a sustainable future powered by renewable energy, as your insights and perspectives will undoubtedly enrich the discussions and contribute to the success of this global event.

- Forge the path forward: Engage in high-level dialogues with fellow Ministers and industry leaders to identify concrete and actionable steps for tripling renewable energy capacity worldwide by 2030.
