The main objectives of the meeting are to:

- Review the epidemiology and virology of respiratory virus illness during the winter period 2023/2024;
- Share experiences in conducting integrated epidemiological and virological assessments and discuss the future strategic direction of indicator and event-based surveillance;
- Explore priorities, opportunities and challenges for RSV surveillance within integrated surveillance of respiratory viruses;
- Assess the suitability of current national severe disease surveillance systems for: a) routine epidemiological assessment; b) detection of novel/unexpected severe respiratory illnesses.

The ECDC Missions and Meetings office will organise the logistics for your trip and ECDC will cover the costs of your travel, accommodation and daily subsistence allowance according to the <u>Rules for</u> reimbursement of expenses incurred by invitees invited by ECDC<sup>1</sup>.
