The programme of The Hague Colloquium starts at 15.00 on Thursday, 13 November with a meeting between the Network and The Hague Judicial Club bringing together the Dutch Supreme Court and the international courts and tribunals based in The Hague. Friday, 14 November is devoted to the Colloquium and the General Assembly of the Network. The conference day is divided into two independent working sessions. The morning session focuses on *"National Courts and International Crime"* and will be prepared and moderated by Mr Christophe Soulard, First President of the French *Cour de cassation*. The afternoon session provides an opportunity for an exchange of ideas on *"Social Media: its Impact on Court Communication and Influence on Judicial Independence"*. This session will be prepared and moderated by Ms Bettina Limperg, President of the Federal Court of Justice of Germany. Both moderators will circulate a set of preparatory questions prior to the Colloquium to ensure a lively debate.

The working day will conclude with the General Assembly of the Network, open to all Members, Associate Members and Observers of the Network.

The conference day on Friday will be followed by a dinner. The Colloquium will conclude with a social programme and lunch on Saturday, 15 November. The preliminary programme of The Hague Colloquium is enclosed.
