Thank you for your email and for highlighting the issue.

During the manual application of curtailment on the EE-LV border for delivery day 27/05 in our allocation system, the system operator (TSO) was mistakenly selected as Elering instead of AST.

As a result, the curtailment template that was generated and published incorrectly displayed Elering as the TSO. This has now been corrected, and the publisher has been updated to AST.

We hope this is acceptable. However, if you notice any impact on your end, please let us know.

Thank you for your understanding, and we apologize for any inconvenience caused.

We have noticed that there is an EE-FI FTR curtailment message published for 27.05.2026, and the message indicates that the curtailment was initiated by Elering.

Based on the information available to me, Elering has not submitted such a curtailment request. Could you please verify and clarify on what basis this information was published? If the actual curtailment request originated from AST, please amend the message board information as soon as possible.

This is important, as the Estonian NRA has taken the position that FTRs should not be curtailed under any circumstances, and Elering has today received an official notice from NRA regarding a potential injunction related to this curtailment.

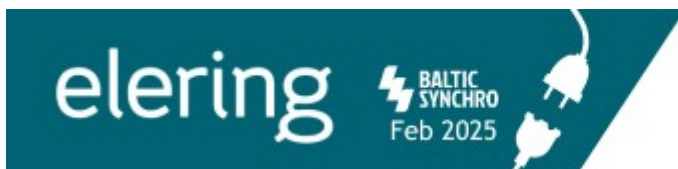
