Dear Sir or Madam,

At the request of the Chief Scientist of WHO, this is to kindly invite you to express interest in the vacant seat in category 3 membership of the Policy and Coordination Committee (PCC) of the Special Programme of Research, Development, and Research Training in Human Reproduction (HRP).

The Policy and Coordination Committee (PCC) is the governing body of the UNDP-UNFPA-UNICEF-WHO-World Bank Special Programme of Research, Development and Research Training in Human Reproduction (HRP).

The membership of PCC is described in paragraph 2.2 of the MOU, and includes as category 3, two members elected by PCC for three-year terms from interested remaining Cooperating Parties. The term of office of one member in category 3 will come to an end on 31 December 2025. It will therefore be necessary for an election to take place at the Thirty-eighth meeting of PCC, which will take place in Geneva and on 29 and 30 April 2025.

The term of office of the newly-elected member will run from 1 January 2026 to 31 December 2028.

Under the terms of the HRP MOU, all governments are eligible for election under category 3, except those that are already a member under Category 1 or Category 2.

For the European Region, the following Member States are members of the PCC:

Category 1: Belgium (Flemish Government), Netherlands (Kingdom of the), Norway, Sweden, Switzerland, United Kingdom of Great Britain and Northern Ireland

Category 2: currently Italy followed by Romania starting from 1 January 2025

Category 3: Armenia

Applications should be sent by 27 February 2025 directly to Dr Pascale Allotey, Director of the Special Programme (and), outlining the motivation for applying, specifically noting work on family planning, research and development and in human reproduction and fertility regulation, as demonstrated by national policies and programmes.

Once the member is elected at the April 2025 meeting, an invitation will be extended to the government/organization concerned to nominate their representatives for the three-year term of office on PCC.
